# **COPYRIGHT V. AUTHOR'S RIGHTS**

'Do I have the right to place on an open archive an article I have published elsewhere, and whose publisher is offering a version which must be paid for ?'

- > Check the contract concluded with the publisher. Have you ceded or retained copyright ?
- Consult the publisher's policy on their website or on sherpa.ac.uk/romeo or heloise.ccsd.cnrs.fr
  - > 75% of publishers authorize the depositing of a version of the articles they publish on an open archive.

### **KEEP A CRITICAL MIND!**

- > Do not unilaterally give up all your rights
- > Don't be afraid to negotiate your publication contract
- Suggest inserting a clause in the contract permitting depositing on an open archive
- > When you publish in an Open Access journal pay attention to the license you sign and what it allows or forbids. Creative Commons licenses allow authors to choose what use of their work they authorize

FOR FREE ACCESS TO ACADEMIC AND SCIENTIFIC RESEARCH LITERATURE

The University of Liege is developing a strong proactive policy in terms of free access to research literature, in other words making it available on the Internet at no cost so that it is accessible to all, whilst respecting the author or its rights holders, with no legal, technical or financial barrier other than those inherent to Internet access and use (BOAI 2002).

## **OPEN ACCESS, YOU SAID ?**

Every publication arising from research funded by public money should be freely accessible to every citizen. And yet in twenty years the average cost of a research journal has tripled.

The result: institutions no longer have the means to pay.

### AN IMBALANCE HAS BEEN CREATED

The academic and scientific research community does by far the majority of the work, and very often for no fee. It produces the ideas, carries out the research, finds and writes the articles, as well as correcting and validating them (peer review), before passing them onto the publisher. The latter publishes them, before selling them... back to the research community !

### AT THE ULG: GREEN FIRST !

In terms of Open Access, the ULg's priority is clearly in favor of the Green Road, in other words depositing publications on the institutional repository, **ORB**, after they have been accepted/published via traditional publishing pathways.

ORBi, which is both the institutional Open Repository and Bibliography, brings together and makes freely accessible the University of Liege's research output.

Since 2008, thanks to a vigorous institutional mandate, only the publications logged on ORBi are taken into account for every internal evaluation procedure and every request for credit made to the ULg or to the F.R.S.-FNRS

### THE ADVANTAGES FOR THE RESEARCHER

### > Markedly increased visibilit

- Free and immediate access = more potential readers
- $\rightarrow$  1 hour after being deposited on ORBi, the publication is referenced on Google.
- → And a short time later on Google Scholar, Primo Central, BASE, OAIster, Isidore, OpenAIRE, etc.

It also appears in the results of searches carried out on the ULg Library website.

Greater impact

The publications deposited on ORBi are cited twice as much as those which are not

- Autonomous management of the dissemination of each document
- A permanent safeguard guarantee of all your research output, past and present, on a single portal, permanently available on the web
- > Easier management of publications lists
- Tools which allow publication lists to be integrated into web pages
- > Automatic recovery of bibliometric indicators

## **ORBi ALSO MEANS**

- > Thousands of downloads each day !
- A constant evolution in the number of references being deposited and above all of integral texts: 2/3 of the references on ORBi are accompanied by the integral text... of which over half are in Open Access !

## ALL THAT GLISTERS IS NOT GOLD

The Gold Road offers direct publication in Open Access journals and books.

*The Gold Road* is represented at the ULg by the publication and dissemination portal for academic and scientific research journals, PoPuPS.

### How is the Gold Road funded ?

- > The establishment of a platform subsidized by an organization or an institution (such as PoPuPS)
- > Freemium : access to the articles is free of charge, and only the related services must be paid for
- Paid subscription to an Open Access journal distribution platform (such as *PeerJ*)
- Reversed model : it is the author (and not the reader) who pays. The ULg does not endorse the explosion of costs which this type of *Gold access* at times incurs

BY CONTRAST, the hybrid model IS NOT Open Access : the publisher sells the journal by subscription and in addition makes authors pay if they wish to place their articles on Open Acces

## THE GUARANTEES OF QUALITY

### For the Green Road

These are versions of documents published elsewhere. The finished nature of the shared document can be :

- > before peer reviewing (preprint)
- > after peer reviewing (author's or publisher's post print). The text is thus of the same quality as that of the published article

### For the Gold Road

The academic or scientific validation of a document does not depend on its means of distribution. There are numerous Open Access journals which are peer reviewed. They may furthermore have an impact factor (IF).

The criteria which determine the quality of an Open Access publication are thus the same as for other publications.
